- 2. This promotion would be subject to the following:
 - a) The officers have been absorbed in MTNL on permanent basis.
 - b) No disciplinary/vigilance case is pending against the officers or vigilance clearance is withheld in terms of instructions contained in GOI (DOP&T) OM No. 22011/4/91-Estt.(A) dated September 14, 1992.

- 3. The promotion shall be effected notionally w.e.f. 18/07/2012. However, actual financial benefits may be accorded with effect from the date the officer assumes charge in the grade of Dy.
