## OFFICE MEMORANDUM

Subject Provision of another "one-time option for pro-rata pension holders to opt for Combined service pension" in view of giving effect to amendment in Rule37 A with retrospective effect in MTNL

The undersigned is directed to forward a representation dated 4.03.2014 from President, MTNL Staff Union, on the above subject. In the representation, the blowing issues have been mentioned.

- (i). The employees who opted for pro-rata pension on absorption in MTNL may be given one more opportunity to get pension on the basis of combined service in the Government and MTNL.
- (ii) There is also a large section of employees who were recruited by Government of India but could not complete 10 years qualifying services as on 1.11.1998 and opted for pro-rata pension but were deprived of pension for the services rendered under Government of India as they were not eligible for pension under Government of India Rules enforce at that time.

The issue mentioned at (ii) is not clear, as even the employees who had less in 10 years of service at the time of absorption were eligible to exercise the ion for pension as per Government rules on the basis of combined service, as 10M dated 5.07.1989.

It is requested that the detailed comments of DoT on the representation may use be sent to this office urgently.
