# Sub : - Provision of Discount in Billing Software for MTNL Offices/Officers/Staff

I am directed to state that a committee comprising of senior officers from DoT/BSNL and MTNL was formed in the DoT to resolve the left out issues pertaining to the service connections.

- The recommendation of the committee on the subject are as under: -
  - (i) Both BSNL and MTNL shall provide a discount of 30% on all telephone bills (including mobile and broadband) in FMC, plan charges, Usage Charges etc. for all telephones in offices and residence of the officers/staff on standard-tariff package/plan.

(ii) The telephone charges for telephones including Broadband & leased lines installed/working in offices shall be paid by BSNL/MTNL to each other.

- (iii) The telephone bills of residential connections including Mobile phones provided to the officers/staff shall be paid by the Officers/staff concerned to the billing authority and shall get reimbursement from its respective organization as per their entitlement.
- (iv) The telephones and other services can be got disconnected by the service provider in case of non-payment of bills in time.
- 3. After the submission of the recommendations of the above committee, MOU has been signed between MTNL and BSNL, a copy of the MOU is also attached herewith. You are requested to kindly make necessary modifications/arrangements/changes in the billing software so that the recommendations of the committee can be implemented.
- The recommendations of the committee relating to service connections as mentioned above will be implemented from bills issued on or after 01-01-2014.
- 5. The residential service telephone/mobile/broadband connections provided to the MTNL/BSNL officers/staff may not be disconnected on the old outstanding dues. The old outstanding dues for the period prior to implementation of these instructions may be kept separately by both BSNL & MTNL and may not be included in the current bills.
- Compliance report may kindly be sent to the BSNL C.O.
